

Fleet dashboards may have been around for years, but J. J. Keller's approach to developing our own fleet dashboard was unique. When combined with our electronic logging devices (ELDs), the overall Encompass® system is truly one-of-a-kind.

We began with what we do best: improving safety and regulatory compliance. Then we aimed for total versatility. Combined with 60 years of expertise as a foundation, our Encompass® with E-Logs online compliance management system was built.

A Proven Regulatory Foundation

In the beginning, Encompass® was created primarily to store and manage safety and compliance data and records that are fundamental to running a successful CMV operation. These included drug tests, employment applications, driver qualification records, training records, licenses, registration documents, photos, and company-specific information.

To date, Encompass® has provided thousands of fleet managers, overseeing nearly 500,000 drivers and vehicles, with concrete data about their own fleets and drivers — knowledge they use to control costs and grow their businesses.

Managers of non-regulated fleets also chose Encompass® because it tracks records and data unique to their operations: employee records, company-required documentation, credentials (TWIC cards), and assets like forklifts, generators, and scissor lifts.

But that was just the beginning.

Built for Mobility

With the growth of mobile technology in the marketplace, we recognized that drivers could use the technology they're already comfortable with to meet the demands of increased compliance requirements, including electronic logging. Mobile devices give drivers and companies the greatest opportunity for a flexible E-Log solution. Instead of building a cost-prohibitive, dashboard-mounted system that can't respond nimbly to new technology and regulatory changes, we built Encompass® with an eye toward the mobile revolution.

When we looked at the mobile revolution, it became obvious that soon everyone would have the power of a super computer in their pocket, and all of us would be connected all the time. Why not take advantage of this mega trend? It didn't make sense to ask customers to pay twice for this infrastructure so

we proceeded to make our solution compatible with as many devices as practical.

That led to the development of our J. J. Keller Mobile® app — the only E-Log/E-DVIR app compatible with the iPhone®, iPad®, and over 80 Android™ devices. We also developed what is now our Gen II ELD. It's the only Apple®-certified ELD we know of that's compatible with all vehicle classes (1-8). Together, they collect and transfer data via Bluetooth® to the cloud-based Encompass® back office system. Fleet managers can now view, report, track and analyze compliance and performance levels at the touch of a button. A simple, but powerful, mobile model.

This "flexible mobility" is the cornerstone of delivering the right electronic logging system. And it allows fleets to use their choice of commercially-available smart devices to work with Encompass*.

Imagine how much better your fleet will run with compliance and performance information at your fingertips.


